Promotion Rules – Effective May 2026

**TERMS AND CONDITIONS |** Applicable to Lantern Club's State of Origin – Retro Jersey Promotion

1. Instructions on how to enter the promotion and other details contained within promotional advertisements for this competition form part of the conditions of entry.
2. By entering this promotion, entrants agree to abide by these terms and conditions.
3. The promotion is open to all members and visitors of Lantern Club.
4. The promotion period is on 27 May, 2026, 17 June 2026 and 8 July 2026, from 16:00 until the official conclusion of the game.
5. To enter this promotion, an entrant must:
  - a) Be 18 years of age or over
  - b) Purchase a tap schooner of Toohey's New (only) at Lantern Club to receive 1 entry ticket per schooner.
  - c) Place their entry ticket in the promotion barrel located at the main bar at Lantern Club
6. Purchases of any packaged product do not receive entry tickets into the promotion.
7. Each entry ticket will need to be filled out but the member or visitor with the member or visitor's full name, phone number and Lantern Club membership number (if applicable).
8. Multiple entries by the same entrant are permissible.
9. There will be one (1) prize to be won during promotional period on 27 May, 2026, 17 June 2026 and 8 July 2026. The prize consists of one Tooheys Retro Jersey (each valued at \$75AUD). Each prize will be randomly drawn by a Lantern Club representative at the official conclusion of each game.
10. All entry tickets will be cleared from the promotion barrel after each prize draw.
11. The winner must be present at the time of draw to claim their prize. If winner is not present, subsequent draws will take place until an eligible winner is found.
12. All winners must claim their prize within 4 minutes or a redraw will occur immediately. This will take place until a winner claims their prize.
